THE TRAINING SITE

UF Health Jacksonville, (formerly Shands Jacksonville) Emergency Department sees approximately 100,000 patients per year; the Florida/USVI Poison Information Center-Jacksonville is one of three centers in a statewide network facilitating the assessment, management and prevention of poisonings in North and Central Florida. On call Toxicology fellows (1first year Pharm.D., 1-second year Pharm.D.) and board-certified toxicologists provide support for complicated poison center cases and bedside consultative services for admitted patients. Seven board certified toxicologists (5 Pharm.D., 2 MD) are on faculty to assist in the fellow training.

CLINICAL TOXICOLOGY EMERGENCY MEDICINE FELLOWSHIP

This 24-month program will serve to educate and provide practical experiential training for the fellow in aspects of those subspecialties (emergency medicine, adult and pediatric care, clinical toxicology and poison information) necessary for the development of expertise in diagnostic procedures, triage, initial and subsequent therapeutic management, and monitoring of the acutely ill patient; with emphasis on human toxic exposures.

Thorough knowledge of emergent, urgent and critical care therapeutics and their relationship to toxicologic problems will allow the fellow to discuss pathophysiologic entities and formulate therapeutic and monitoring protocols on a hands on, case-by-case basis.

The curriculum will prepare the fellow for successful completion of the American Board of Applied Toxicology certification exam.
